In case of failure by the Contractor to supply the performance guarantee within the specified period, full earnest money will be forfeited and the tender shall be treated as void. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

Applications in person for issue of tenders should accompany the following: -

1. Firms/Contractor must have completed satisfactory one similar work amounting to Rs 16.50lacs or two similar works each amounting to Rs.10.30lacs or three similar works each amounting to Rs 8.24lacs during last 7 financial years for the subject work.
2. Cost of tender Rs. 500.00 (Rs. Five hundred) in cash deposit in S.B.I. or Canara Bank at IIT Delhi. (Non- refundable).
3. Earnest money amounting to Rs.41102/- in the form of Deposit at Call receipt of Scheduled Bank guaranteed by the Reserve Bank of India or Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.
4. Attested valid TIN Registration Certificate under D-VAT (including preferably deposit receipt etc.)
5. Attested copies of Completion certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
6. Attested copies of Registration of firms/contractors must be valid on the last day of issue of tenders or extended date of issue of tender.
