The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

- 2. Cost of tender **Rs. 500.00 (Rs. Five hundred)** in cash deposit in S.B.I. or Canara Bank at IIT Delhi. (Non- refundable).
- 3. Earnest money amounting to **Rs.45977**/- in the form of Deposit at Call receipt of Scheduled Bank guaranteed by the Reserve Bank of India or Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.
- 4. Attested valid TIN Registration Certificate under D-VAT (including preferably deposit receipt etc.)
- 5. Attested copies of Completion certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
