TERMS AND CONDITIONS

- 1. The rates quoted by the bidder, shall be firm and inclusive of all taxes (including GST), duties & levies, etc. and all charges including risk, overhead charges, general liabilities / obligations and clearance from concerned authority if any.
- 2. Payment shall be made after completion of work followed by submission of bill.
- 3. Nothing shall be paid extra in labour / material rates
- 4. No advance payment will be made to the contractor
- 5. Work shall be carried out as per direction and to the entire satisfaction of the Engineer-in-charge
- 6. Necessary compensation as per clause IITD 7 / 8 as applicable, MAY BE IMPOSED IFREQUIRED.
- 7. Necessary Taxes as applicable shall be deducted from bill of the contractor
- 8. Non judicial stamp paper worth Rs.10/- will be sent for completion of work order which will have to be signed in token of acceptance.
- 9. Work shall be completed as per CPWD specifications.
- 10. Nothing will be paid extra in labour rates/ items rates.
- 11. For bad work suitable penalty will be imposed and recovery will be made from the bill of the contractor.
- 12. The time period for the execution of the work will be **07 Days** from the date of issue of the work order.
- 13. No advance payment will be made to the contractor.
- 14. Storage of material inside the IIT campus is strictly prohibited.
- 15. Income tax as per rules deducted from the bill of the contractor, where the value of the contract exceeds Rs. 10, 000/- including enhancement.
- 16. Material should be shown/inspected to the concerned Engineer in –charge / supervisor before installation.
- 17. Work will be the completed to the entire satisfaction of the engineer in-charge.
- 18. Incomplete work will be got done at the risk and cost of the contractor.
- 19. No .T & P shall be issued by the institute and contractor has to makes his own arrangement.
- 20. The work shall be executed as per program draw by the Engineer In-Charge. Necessary compensation (AS per CPWD, 7& 8) will be imposed in case; it is found that the contractor is intentionally delaying the execution of work.
- 21. The contractor shall maintain in good condition all works –executed till the completion of entire work allotted to him.
- 22. The contractors shall be responsible for any injury or accident to the labour working at site and no claim shall be given by the institute.
- 23. Recovery for the damage hand done of the institute Building by the contractor or his labour will made from the bill of contractor.
- 24. GST @18% will be applicable from the bill of the contractor.
- 25. I. Tax @2% & Cess @1% will be deducted from the bill of the contractors.
- 26. The envelope containing quotation documents must be properly sealed.
- 27. Use of correction fluid in quotation/ tender documents not to be allowed such quotation /tenders is liable to be rejected.
