Vertical Deep Freezer <u>Technical Specifications</u>

Deep Freezer should meet following minimum specification:

- Temperature: 60 deg C or lower
- Capacity: Minimum 300 L
- Vacuum insulated panels
- Inner tank material stainless steel SS 304
- The door seal must be sealed with a triple silicon section seal.
- It must be fitted with decompression valve facility to lower air pressure, inside the freezer for easy door opening
- Must have adjustable sample compartments
- Thermal conductivity: <0.005W
- Temp. stability +/-1deg C & Uniformity +/-3Deg C
- Silicon sleeved type K thermocouple temp. sensor
- PID Control Interface with temp. set, start-stop, Audible & Visual faultacknowledge buzzer, temperature alarms, & condenser fault alarm & Remote alarm system
- Power requirement not more than 1200 W
- Operating temperature up to + 38 Deg C

All necessary accessories/spare parts/consumables should be quoted for smooth and trouble free operation of the equipment for minimum 3 years.

Terms and Conditions

Original Equipment Manufacturer (OEM) should be submit their bid directly.

Quotation shall remain valid for a period not less than 90 days after the deadline date specified for the submission.

The instrument should be with onsite comprehensive warranty for a minimum period of Three year after satisfactory installation.
