- The successful firm (s) will have to enter into an agreement on a non-judicial stamp paper of appropriate value, the cost of which has to be borne by the firm itself
- 4. Delivery Period 1 to 8 weeks from the date of receipt of orders and delivered to Central Library, IIT Delhi. A penalty @ 0.5% per month of order value will be imposed in case the supply is not executed within the stipulated period and the same will be deducted from any pending bill.
- 5. No change in rates on higher side will be allowed after acceptance of tender.
