#### 1. Background

IIT Delhi has 5x2Mbps Internet connectivity with point to point leased circuits from VSNL and ERNET. It also has 1Gbps Internet bandwidth from NKN and 232 Mbps from Reliance. IIT Delhi wants to acquire Internet Bandwidth of 1Gbps(1:4) / 200Mbps (1:1) as a backup support to NKN (1Gbps) for increased reliability while keeping 4X2Mbps circuits from VSNL and 1x2Mbps circuit from ERNET.

The work includes supply and installation of 1Gbps(1:4) / 200Mbps(1:1) **Internet Leased Line** and accompanying accessories as per the tender specifications and providing two Class C IP Addresses for Internet connectivity. Either 1Gbps (1:4) or 200Mbps (1:1) Internet Bandwidth is required to be supplied over the channel. IIT Delhi reserves the right to order for either 1Gbps(1:4) or 200Mbps(1:1) Internet Leased Line. Route scanning through appropriate machines is required to be done for obtaining clearance for carrying out fiber layout in order to avoid damage to the existing underground services and roads.

Sealed tenders are, therefore, invited from reputed vendors for the aforesaid purpose as per the details given in the **Annexure-I to Annexure-VII. These details are available on the Institute Web site:** <a href="http://www.iitd.ac.in/tenders">http://www.iitd.ac.in/tenders</a>

# 2. <u>Eligibility Criteria of Bidders:</u> ( Please refer to <u>Checklist for fulfilment of "Eligibility Criteria for bidders"</u> given in <u>Annexure-II</u>)

- (i) The bidder must be a Class A ISP license holder with Points of Presence (POPs) in major cities in the country (List of POPs to be provided by the bidder). The bidder must be a reputed National Level Internet Service Provider (ISP) with a Significant Presence in Delhi/NCR.
- (ii) Bidder should possess a valid DoT license, which grants them the authority to set up and operate International Gateways on submarine cables. A copy of the DoT license must be provided by the bidder along with the bid.

The bidder should provide documentary proof of having successfully installed at least three 1Gbps(1:4) / 200Mbps(1:1) Internet Leased Line at any Indian educational institution and/or Industrial organization of repute in the past three financial years.

- (iii) The bidder must provide documentary evidence of current user base in NCR/Delhi. The bidder must give documentary evidence that it is currently providing Bandwidth exceeding 1Gbps(1:4) / 200Mbps(1:1) each to at least 3 distinct educational and /or industrial organizations of repute in NCR/Delhi. A recent certificate of satisfactory performance from these customers must be provided. The bidder must provide complete contact details of these institutions, in order to allow IIT Delhi to independently verify the claims made by the respective bidders.
- (iv) Bidder should have State of the art Network Management centre and Network Operation Centre which operates on a 24\*7 basis. Bidder should be able to provide Trouble Shooting Services round the clock at these locations to ensure uninterrupted service.
- (v) Bidders are required to submit their profile vis-à-vis Internet Bandwidth providing Business. Bidders are also required to provide detailed information indicating the available infrastructure in their organization. This list must include details regarding active and passive networking components and Network Management software available at the various Points of Presence (POPs) in India. Bidders are also required to attach documents indicating the current availability of staff for testing, commissioning and for providing after sales service. If the bidders has quoted active and/or passive networking components then the bidder should attach separate undertakings from the respective manufacturer (OEM)/Copyright owner (for any software component quoted as part of the bid) stating that they would facilitate the bidder on a regular basis with technology/ product updates and extend support for the warranty for all the products being quoted by the bidder with respect to this particular tender.
- (vi) The bidder must have a minimal annual turnover of more than Rs. 5 crores in each of past three years (2008-2009, 2009-2010 and 2010-2011) and the bidder should have reported net profits for each of the past three financial years (2008-2009, 2009-2010 and 2010-2011). Bidder should submit certified copy of audited accounts for this purpose.
- (vii) Bidder should submit a Copy of category A ISP license and LST/CST/WCT No. and the PAN Number allotted by the concerned authorities.
- (viii) Solvency certificate with a value of Rs 2 crore or working capital

- certificate as the case may be, should be obtained from any Nationalized/Scheduled bank. The bidder should attach this document with the bid
- (ix) Earnest Money Deposit as mentioned in Section 5 of this document (draft should be kept properly in an envelope Entitled Earnest Money)
- (x) The terms/conditions for supply/payments etc. should be given on Non Judicial Stamp-paper of Rs. 100/- duly attested by Notary with two witnesses and attached with the quotation.
- (xi) The bidder should have sold minimum total aggregate of 10 Gbps of International bandwidth capacity to its clients in India either from Europe / USA India or Asia Pacific

#### 3. Obtaining Bid Documents

- (i) The bid documents shall be available for download from I.I.T. Delhi website http://www.iitd.ac.in/tenders.
- (ii) Bidders must note that in order to participate in the Pre-bid meeting and in the tendering process they must deposit a non-refundable fee of Rs. 500/- in the form of demand draft of any Nationalized/ Scheduled Bank payable at New Delhi in favour of "**Registrar, I.I.T. Delhi**" by 05:30 PM on or before 29th February, 2012 in the office of Head Computer Services Centre, I.I.T. Delhi.
- (iii) The bidders should write the name of their company and super scribe "Supply and Installation of 1Gbps (1:4) / 200Mbps (1:1) Internet Leased Line: Computer Services Centre IIT Delhi" on the reverse side of the bank draft.

## 4. <u>Submission of Proposals</u>

(i) The bidder shall go through the entire document and must comply with all the terms and conditions. A Compliance statement in the form of 'Complied' or 'Not Complied' shall be given against each item and specification of the tender document. The compliance statements should be supported by authentic documentation. Please note that any deviation from the laid down requirements/specification shall be brought out separately in deviation sheets to be attached with concerned section of the tender. Failure to comply with this requirement may result in the bid being rejected. Each page of the bid and cuttings / corrections shall be duly signed and stamped by the bidder. Failure to comply with this requirement may result in the bid being rejected.

- (ii) The proposals shall be submitted under SEALED COVER in two parts and should be super-scribed as "PART-I: COVER FOR TECHNICAL BIDS" and "PART-II: COVER FOR COMMERCIAL BIDS.
- (iii) **Part-I** shall be a **Technical Offer** with full details including description of Hardware / equipments so as to enable technical assessment of the proposal. This shall also include Earnest Deposit Money as per **Section 5** and categorical clause wise compliance statement as per **Annexure-II.**
- (iv) The **Technical bid** must be submitted in an organized and structured manner. No brochures/leaflets etc. should be submitted in loose form. The Technical Offer should comprise of the following:
  - a.) A letter of authority duly signed by an authorized signatory from the company the bidder claims to represent, stating that the bid has been prepared with the complete knowledge of the company, and that the company will honour all commitments made as part of the bid if they receive the purchase order.
  - b.) Complete Bill of Material including all active and/or passive networking components along with Make, Model, Manufacturer, & Part Number.
  - c.) Technical Documentation [Product Brochures, leaflets, manuals etc.] required for proper installation, testing, commissioning of active and/or passive networking components and accompanying accessories. If any Technical Documentation has to be accessed from the Website of the respective manufacturer/OEM, then the same must be clearly indicated in the Technical Bid. The bidder then must also provide the complete URL address of the Website where the relevant information is available.
  - d.) Delivery and implementation schedule. The bidder should explicitly acknowledge that they have read the terms and conditions as mentioned in the following clause "Supply and Installation", and agree to the terms and conditions mentioned therein.
  - e.) Compliance of terms, with any deviation clearly indicated in remarks & brought in separate deviation sheets. The bidder should carefully fill up the all the checklist provided as part of the Bid Documents.
  - f.) Warranty and AMC (Comprehensive Annual Maintenance) details.
  - g.) Columns related to commercials must not be filled up.
  - h.) The bidders must note that in addition to submitting a hardcopy of the technical bids, they must also submit soft copy of the technical bids inclusive of all the documents as mentioned above in a Compact Disc (CD). The entire technical document should be in PDF (.pdf) format

- (v) **Part -II** should contain The Commercial Bids for the entire proposal with breakup of the prices for 1Gbps(1:4) Internet Bandwidth [Annexure III(a)] or 200Mbps(1:1) [Annexure III(b)] Internet Bandwidth or both. The bidder must provide a minimum fixed reduction of 25% of Base price + variable reduction of x% of Base Price in each subsequent year starting from the 2<sup>nd</sup> year (ie. 2<sup>nd</sup> year, 3<sup>rd</sup> year and 4<sup>th</sup> year) during the contract period, where x% will be separately quoted by the bidder.
- (vi) IIT Delhi reserves the right to either request for increase in the Bandwidth or reduction in the prices to the tune of (minimum 25% + variable x %) of the Base Price in the 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> year as discussed in point 4(v) above.
- (vii) All prices shall be fixed and shall not be subject to escalation of any description. The Bidder must quote for 1Gbps(1:4) or 200Mbps(1:1) Internet Bandwidth or both. The rates must be quoted as per the Price Formats provided in **Annexure-III(a)** and **Annexure III(b)** including the following:
  - I. All costs should be given in INR both in Figures and Words.
  - II. Govt. Levies like Sales Tax, Octroi, Excise Duty, Work Contract Tax (WCT), Service Tax and Educational Cess etc., if any, shall be paid at actual rates as applicable from time to time. Rates should be quoted accordingly giving the basic price, duties and taxes etc., if any.
- (viii) <u>Both the covers should first be sealed separately</u>, and then both the covers should be kept <u>in a single sealed bigger cover</u>. This envelope should be duly signed by an authorized signatory and should bear the inscription as given in the tender notice.

(ix) **Bids Acceptance**: The Bids must reach the office of Head Computer Services

Centre, I.I.T. Delhi, on or before the due date, i.e., on 13<sup>th</sup> March, 2012 at 3.00 **P.M.** In the event of due date being a closed holiday or declared Holiday for Central Government offices, the due date for submission of the bids will be the following working day at the appointed time & venue. The technical bids will be opened on the same day i.e. on 13<sup>th</sup> March, 2012 at 3.30 **P.M.** in presence of the bidders. **Bids will not be accepted after the due date and time.** All bidders whose technical bids are found to be complete in all respects, in accordance with the Technical requirements and specifications as laid down in this Tender document will be invited for a second round of meeting where the commercial bids submitted by the bidders will be opened and evaluated. The date for opening of commercial bids will be intimated to the bidders.

(x) <u>Validity of bids:</u> Bids should be valid for a minimum period of 90 days after the due date of submission of the Technical Bids.

#### 5. <u>Earnest Money Deposit</u>

- a.) Each bid must be accompanied by Earnest Money Deposit of **Rs.1,00,000/-** (**Rupees One Lakh only**) in the form of Demand Draft/Pay Order/Bank Guarantee of any Indian Nationalized Bank taken in the name of 'Registrar, I.I.T. Delhi', payable at New Delhi, strictly in the prescribed Proforma (**Annexure-V**).
- b.) The Bank Guarantee should be valid minimum for a period of 180 days from due date of the technical bids. Quotations received without Earnest Money Deposit are liable to be rejected. It should be a part of Technical Bid.
- c.) Earnest Money is liable to be forfeited and bid is liable to be rejected, if the bidder withdraw or amends or impairs or derogates from the tender in any respect within the period of validity of the tender.
- d.) The Earnest Money of all unsuccessful bidders shall be returned within one week of finalization of contract with the successful bidder. No interest will be payable by I.I.T Delhi on the Earnest Money Deposit returned to the unsuccessful bidder.
- e.) If the successful bidder fails to furnish the Performance Security within 15 days of the placement of the purchase order, the Earnest Money Deposit shall be liable to be adjusted by I.I.T Delhi against Performance Security (vide <u>clause 12</u>).
- f.) The Earnest money of the successful bidder will be returned after the successful bidder deposits the Performance guarantee to IIT Delhi.

## 6. Rejection of Bids

- (i) I.I.T. Delhi reserves the right to accept or reject any bid or cancel the tender proceedings without assigning any reason whatsoever.
- (ii) If a bidder gives wrong information in their bid, I.I.T. Delhi reserves the right to reject such bid at any stage and forfeit the Earnest Money Deposit / Performance Bank Guarantee and cancel the contract, if awarded.
- (iii) Incomplete quotations are liable to be rejected.
- (iv) If the technical offer contains any price information the offer will be summarily rejected.
- (v) Canvassing in any form in connection with the tenders is strictly prohibited and the bids submitted by the bidders who resort to canvassing are liable for rejection.
- (vi) I.I.T. Delhi shall not pay any costs incurred towards preparation and submission of the bid or any other expenditure in this regard.
- (vii) Unsigned tenders, unattested corrections and over writings in the Technical Bid and/or the Commercial Bid are also liable for rejection.
- (viii) Bids not adhering to the Technical and/or Commercial specifications as mentioned in this document will be out rightly rejected. The bidders must attach all documents including but not limited to technical specifications, commercial specifications and brochures etc as proof of compliance with technical and/or commercial specifications as mentioned in this document.
- (ix) Conditional bids will be summarily rejected.
- (x) The schedule for accepting the tenders shall be strictly followed and submission of late tenders shall not be accepted.

## 7. <u>Evaluation Process</u>

For the bidders satisfying the Qualifying Criteria and Technical Specifications, the price comparisons shall be made separately for both 1Gbps(1:4) Internet Bandwidth and 200Mbps(1:1) Internet Bandwidth over the total cost of the project over a period of four years from the date on which the successful bidder starts providing the service to IIT Delhi. IIT Delhi reserves the right to order for either 1Gbps(1:4) or 200Mbps(1:1) Internet Leased Line. Bidders must note that financial bids of bidders who satisfy all the "Eligibility Conditions" and "Technical Specifications" as mentioned in this document will only be opened. The date of opening of financial bids will be intimated to all bidders whose bids satisfy all the "Eligibility Conditions" and "Technical Specifications" as mentioned in this document.

#### 8. Purchase Order, Prices & Payment Terms

- (i) At the time of placement of purchase order, IIT Delhi will make an advance payment of one quarter of Internet charges subject to a Bank Guarantee of equal amount being lodged with IIT Delhi.
- (ii) The Installation charges shall be paid on satisfactory commissioning and acceptance of the network.
- (iii) Subsequent payments will be made on quarterly basis subject to continued good performance as per committed SLA. It is the responsibility of the supplier to provide reports of IIT Delhi usage and traffic to demonstrate that the SLA is being met. IIT Delhi also requires that the vendor provide a detailed monthly report of the IIT Delhi usage. The detailed monthly report must also list usage in terms of different traffic categories: web, ftp, email, voice, video, etc.
- (iv) Payment of taxes and other applicable Government levies will be made according to the rules and regulations as existing on the date of the payment.
- (v) IIT Delhi would prefer the mode of quarterly post payment. However, quarterly advance payments can be paid subject to submission of a Bank Guarantee of equivalent amount.

#### 9. Clarifications

In case the bidder requires any clarification regarding the tender documents, they are advised to attend the Pre-bid meeting in I.I.T. Delhi Campus in the CSC Committee room on 5<sup>th</sup> March, 2012 at 03:00 PM.

The bidders must submit their queries in writing to IIT DELHI (Computer Services Centre: Attn: Head, CSC) at least one day before the Pre-bid meeting. The Pre-bid meeting will be limited to only those bidders who have paid the non-refundable fee (Rs. 500/- by Demand Draft)

## 10. Quantity Variations

The proposed requirement of bandwidth is subject to change depending on IIT Delhi priority vis-à-vis financial constraints, if any.

## 11. <u>Inspection</u>

IIT Delhi shall have the right to inspect or to test the items at the time of supply to confirm their conformity to the required specifications. The supplier shall provide all reasonable facilities and assistance to the inspector at no charge to IIT Delhi.

In case any inspected or tested goods fail to conform to the Technical and/or commercial specifications as laid down in this tender document, IIT Delhi will have the right to reject the goods supplied by the supplier and supplier shall either replace the rejected goods or make all alterations necessary to meet the Technical and/or Commercial specification as laid down in this Tender document free of cost. IIT Delhi will be the final authority with respect to all decisions regarding replacement and/or repairing of faulty equipment, and the successful bidder will have to necessarily execute all instructions related to repair/replacement of faulty equipment as issued by IIT Delhi.

#### 12. Performance Security

- a) The successful bidder shall be required to furnish Performance Security within 15 days of the placement of purchase order as under strictly in the prescribed Performa (**Annexure-VI**).
- b) The successful bidder shall submit a Performance Security of 5% of the total cost of the order.
- c) The Performance Security must be in the form of Demand Draft/Pay Order/Bank Guarantee of any Indian Nationalized/Scheduled Bank.
- d) The Performance security should be valid for a minimum period of (48+2) 50 months. In case supplier fails to deliver the items within delivery period or provide satisfactory after service within the warranty period, the Performance security submitted by the bidder is liable to be revoked and the Institute will claim the Performance security.
- e) Failure to comply with this condition would render for adjustment of Earnest Money Deposit and furnishing for the balance amount without further delay.
- f) Performance security shall be released after two months on the satisfactory completion of warranty period. No interest will be payable by IIT Delhi on the Performance security.

## 13. **SLA**

The bidder should commit to a detailed SLA, which clearly outlines Bandwidth as well as Latency, and Drop Rate commitments. The SLA must also list out the commitments on service for Faults. Faults, if any, shall be attended to on immediate basis but in no case any fault should prolong for more than 8 hours. The bidders should attach a document along with the bid stating all service terms and conditions of the connection. (See Annexure IV)

#### 14. Supply and Installation

- a.) This is a time bound and high priority project. It must be understood that the successful bidder has made the proposal after fully considering all such factors, which may have any bearing on the time schedule. The bidder will be required to supply, install and enable services within 4 weeks from the date of placement of order.
- b.) The successful bidder will have to arrange for all the testing equipment & tools required for installation, testing & maintenance etc. at his own cost.
- c.) The successful bidder will ensure smooth integration of the proposed link with the Active Components and/or Video Conferencing equipment existing at IIT Delhi.
- d.) The successful bidder's personnel will help with setting up BGP advertisements of IIT Delhi's own as well as additional IP addresses through their network. The bidder will also work with IIT Delhi to provide a BGP failover to alternate links in case of problems with the 1Gbps (1:4) / 200Mbps (1:1) links.

### 15. <u>Liquidated Damages</u>

If the supplier fails to deliver any or all of the goods or complete the installation within the period specified in the purchase order, IIT Delhi shall without prejudice to its other remedies, deduct as liquidated damage 0.5% of the price of the delayed goods for every week or part thereof subject to a maximum of 5% of the order value. The amount towards Liquidated Damage would be recovered while making the initial payment itself.

## 16. **Penalty Clause**

In case of non-supply of goods after the acceptance of purchase order, Earnest Money Deposit/ Performance security will be forfeited of the defaulting bidder and the supply order shall be placed with the next bidder which has quoted the next lowest rates at the risk and cost of the defaulting bidder and difference, if any, between the total cost of the materials shall be chargeable to the defaulting bidder. In case the defaulting bidder fails to pay the differential cost, the legal action shall be taken against the defaulting bidder. IIT Delhi would also have the liberty to "Blacklist" the defaulting bidder. This would imply that the defaulting bidder would be debarred from participating in any tendering process for supply of equipment and/or rendering of services to the concerned institute.

## 17. Force Majure

Any delay due to Force Majure will not be attributable to the vendor.

## 18. Arbitration and Laws

Except where otherwise provided for in the contract, all questions and disputes relating to interpretation and application of the provisions of the contract shall be settled mutually within thirty (30 only) days (or such longer period as may be mutually agreed upon) from the date that either party notifies in writing that such dispute or disagreement exists, under the Rules of Indian Arbitration and Conciliation Act, 1996. The venue of Arbitration shall be New Delhi, India. The arbitration resolution shall be final and binding upon the parties and judgment may be entered thereon, upon the application of either party by Delhi court having jurisdiction. The Indian laws shall govern this contract.

## 19. **Termination Clause**

Either party can terminate the service agreement by giving three months notice in advance. In case, the bidder stops service without notice, IIT Delhi will have the right to revoke the bank guarantee in its favour.

### 20. Price Variation

Notwithstanding any other clause contained in this document, IIT Delhi will retain the right to review the total charges to be paid to the successful bidder for the purpose of providing internet connectivity on an annual basis. This review will be carried out three months prior to the end of the annual contract period. However no request for upward revision will be entertained.

# Annexure-I: Technical Specifications for 1 Gbps(1:4) / 200Mbps (1:1) Internet Leased Line

#### **Internet Bandwidth:**

Total 1 Gbps (1:4) / 200 Mbps (1:1) Internet Bandwidth.

Last Mile connection from the PoP of the service provider to the IIT Delhi Campus should be High Availability and on Optical fiber.

#### **Service Description:**

Dedicated Symmetric International Bandwidth by peering with local POP of bidder to IIT Delhi. The bidder must guarantee availability of 1:1 bandwidth for 200Mbps (1:1) or 1:4 bandwidth for 1Gbps (1:4) on their backbone for IIT Delhi from their peering PoP up to gateway router. The bidder must also ensure that bandwidth on their backbone will be meant for International traffic only and local traffic for IIT Delhi from their users should not be allowed.

#### **Delivery:**
