## MINUTES OF 234<sup>th</sup> MEETING OF THE SENATE HELD ON 30<sup>th</sup> JULY 2025 AT 03:00 PM IN THE SENATE ROOM

The 234<sup>th</sup> Meeting of the Senate was held on 30<sup>th</sup> July 2025 at 03:00 pm in the Senate Room. Names of Members/Special Invitees, who attended the meeting, are given in **[Appendix – A]**.

Due to non availability of the quorum, the meeting was adjourned at 3:05 p.m. and reconvened at 3:10 p.m.

At the outset, the Chairperson Senate thanked the outgoing Special Invitee for his valuable contributions and welcomed the new Members / Invitee to the Senate. The list of the outgoing and incoming Members / Invitees is given at [Appendix - B].

# <u>Item No. 1</u>: Confirmation of minutes of (a) 233<sup>rd</sup> meeting of the Senate held on 28<sup>th</sup> May 2025 (b) Special meeting of the Senate held on 11<sup>th</sup> June 2025, (c) Special meeting of the Senate held on 10<sup>th</sup> July 2025

The minutes of the 233<sup>rd</sup> meeting of the Senate held on 28<sup>th</sup> May 2025, (b) Special meeting of the Senate held on 11<sup>th</sup> June 2025, and (c) Special meeting of the Senate held on 10<sup>th</sup> July 2025, were confirmed.

#### Item No. 2: Action Taken Report on previous meetings of the Senate

The action taken on the following matters of the previous meetings of Senate was presented in the meeting:

### (i) To consider the recommendation of the Committee to explore the effect of generative Artificial Intelligence.

As desired the recommendations have been given wide publicity as they have been placed on the Institute Website.

#### (ii) Request to continue study after award of Diploma

A proposal will be submitted after the decision on the Exit Policy in the new curriculum is taken.

#### (iii) Updated PhD Ordinances

It was informed that the matter has been included in the agenda of the Board of Governors meeting being held on 31st July 2025.

#### (iv) Update on Curriculum review

Associate Dean, Academics (Curriculum) informed that the credits limits for the PG programmes require updation. It was decided that (i) MTech. and M.Des full-time student will have a minimum of 12, and maximum of 18 credits per semester, (ii) MTech. part-time and HVA students will have a minimum of 3, and maximum of 12 credits per semester, (iii) MPP, MA, M.Sc. students will have a minimum of 15, and maximum of 21 credits per semester. This revision was based on updated total credit requirement of the programme. It was also decided that a Committee be constituted to look into the minimum residency period of the programmes, and if students can be allowed to graduate on early completion

of the credits. The report of the Committee will be presented to the Senate. Accordingly, the Credit limits may be revised.

The Senate was also informed that some minor changes have been done to balance the scheduling in the DD2 and the MT6 program.

An update on the approved courses was also provided. A discussion was held regarding the older students registering for the new courses. (i) It was reiterated that new students will not be allowed to register for old courses. (ii) It was decided that old students may be allowed to register for new courses through the recommendations of the AURC or DUGC. The recommendations should confirm that equivalent old courses do not exist and the AURC/DUGC have verified that the student is not precluded from the course due to overlaps, now or in future.

#### Item No. 3: To approve:

- (i) Conferment of Degrees, Diplomas etc. on the successful candidates who have passed the various examinations of the Institute during the Session 2024-2025; and
- (ii) Award of Medals / Prizes / Certificates etc.

The Senate noted that the total number of candidates eligible for the Award of Degrees, Diplomas at the Convocation – 2025 (as on 30.07.2025) would be as under:
