MINUTES OF 231st MEETING OF THE SENATE HELD ON 19th FEBRUARY 2025 AT 03:00 PM IN THE SENATE ROOM

The 231st Meeting of the Senate was held on 19th February 2025 at 03:00 pm in the Senate Room. Names of Members/Special Invitees, who attended the meeting, are given in **[Appendix – A].**

Due to non availability of the quorum, the meeting was adjourned at 3:05 p.m. and reconvened at 3:10 p.m.

At the outset, the Chairperson Senate thanked Prof. A.N. Bhaskarwar, Department of Chemical Engineering, the outgoing member for his valuable contributions to the Senate.

Item No. 1: Confirmation of minutes of 230th meeting of the Senate held on 27.11.2024

The minutes of the 230th meeting of the Senate, held on 27th November 2025 were confirmed, except for item no. 4(4) regarding the composition of HU category courses. It was informed that this matter forms item 2(ii) of the agenda. The decision of Senate can be seen there.

<u>Item No. 2</u>: <u>Action Taken Report on previous meetings of the Senate</u>

The action taken on the following matters of the previous meetings of Senate was presented in the meeting:

(i) To consider the recommendation of the Committee to explore the effect of generative Artificial Intelligence.

It was informed that that meetings with Microsoft were held regarding licenses for CoPilot as part of the existing agreement for their products. Enquiries sent to OpenAI have remained unanswered.

(ii) To consider and discuss the concept note for the new curriculum.

The matter regarding composition of HU category courses was discussed in detail. After detailed discussion, the Senate decided as under:

1. There will be two baskets i.e. (i) Humanities (HU) and (ii) Self, Society & World (SSW). The number of credits in these baskets can be 9 & 6 or 12 & 3 respectively, which will be decided by the AUs for their programs. The HU basket will have courses from the HuSS Department, whereas SSW basket may have courses from HuSS, DMS, SoPP, CRDT, Design and NRCVEE. Courses would typically be in (but not limited to) the areas of public policy, rural development, management, design, value education, humanities and the social sciences.

2. For implementation purposes, Academic units floating courses in the SSW basket will have to commit requisite number of seats in the courses they will float in each semester so as to meet the student requirements in this basket. There will be a Committee to decide courses forming the SSW basket.

The Senate also noted the DFB minutes of the Department of Humanities & Social Sciences not endorsing the reduction in the credits of the HU category from the existing 15 credits.

(iii) To consider the recommendations of the VCSC on the following proposal pertaining to IIT Delhi – Abu Dhabi

(a) New Academic programs for 2025

It was informed that a new Academic Program of B. Tech. in Chemical Engineering has been announced.

(b) Change in criteria for UG Admissions for 2025

It was informed that the new criteria for UG admissions has been announced, and a new cycle of admissions through CAET/ JEE Advanced exam is being operationalized through the JEE/CAET Office, and the Admissions Committee.

(iv) To consider the proposal to change the name of the 'Department of Civil Engineering' to the 'Department of Civil and Environmental Engineering'

The Senate was informed that as decided in the last meeting, the proposal for change of name of Department of Civil Engineering was sent to the Academic Units for comments/feedback. The Senate noted the comments/feedback received from the Academic Units and observed that the proposal was well received by the Academic Units.

After discussion, the Senate recommended the proposal to the Board of Governors for changing the name of Department of Civil Engineering' to the 'Department of Civil and Environmental Engineering'.

(v) Request to continue study after award of Diploma

It was informed that the proposal for re-entry of students, who had chosen to exit the Institute after receiving degree/diploma, is under discussion.

<u>Item No. 3</u>: To consider M.Tech. and MS(R) programmes template as per new <u>curriculum</u>

The Senate was informed that the draft programme templates for the M.Tech. and MS (R) programmes from the Academic Units have been approved by the Curriculum Implementation Committee (CIC) over its several meetings.

After discussion, the Senate decided to circulate the M.Tech. and MS (R) programme templates to the Senators for comments/feedback. It was decided that the final proposal will be presented before the Senate in its next meeting.

Item No. 4: To approve the draft PG certificate template for online PG diploma programs

The draft PG certificate for online PG Diploma programs was presented to the Senate. After discussion, the Senate recommended the draft PG certificate to the Board of Governors with minor change in the Hindi title. The revised certificate is given at **Appendix 1**.

Item No. 5: To consider the proposal received from the Ministry of Education regarding the revision of eligibility criteria for admission to research programs in Indian institutions for candidates with a four-year BS degree

The Senate was informed that the Ministry of Education, via DO Letter No. 13-50/2024/TC dated 20th September 2024, has requested Indian institutes to examine the eligibility of four-year BS degrees for programs that previously required a three-year BSc followed by a two-year MSc. According to the MoE, this change would make Indian institutions attractive destinations for students from four-year BS programs, aligning with the principles set forth in the National Education Policy, which recognizes the four-year BS as a standard undergraduate degree.

The matter was discussed in detail. After discussion, it as decided to send the proposal to the Academic Units for comments/feedback.

<u>Item No. 6</u>: To consider the proposal regarding a Minor area in Biomedical Engineering from the Centre for Biomedical Engineering

The Senate was informed that Centre for Biomedical Engineering has proposed a Minor area in Biomedical Engineering. The objectives of the proposed minor area are to expose and excite students about the role of engineering and innovation in addressing national healthcare needs and to provide opportunity to engage in technology development & entrepreneurship.

The Senate noted that the following courses have been proposed to be available for students to complete minimum 20 credits to qualify for Minor in Biomedical Engineering:
