- All provisionally Selected Applicants called for **Document verification** are advised to fill up and submit the attached format (**Annexure-I**) along with requisite documents, i.e., self-attested copies of Certificates/ testimonials at the time of verification of documents (as mentioned in the application form/ justify the eligibility criteria for the respective position).

## **IMPORTANT INSTRUCTIONS**

- **The candidates must bring the following documents : -**
  - a) Any identity proof (**in original**) issued by Government Authority for personal verification (i.e. Passport/ Voter Identity Card/ PAN Card/ Aadhar Card/ Any Identity Card issued by Competent Authority).
  - b) **All certificates/ documents** etc. as mentioned in the Application Form in **ORIGINAL along with one set of self-attested photocopies** of the same in support of educational qualification, category (if applicable) etc.
  - c) Class 10<sup>th</sup> Mark sheet or Class 10<sup>th</sup> Certificate indicating Date of Birth.
  - d) Qualifying Diploma/Graduation Marksheet and Certificates. The same must clearly indicate the date/month/year of passing the Diploma/Degree Examination.
  - e) Caste Category certificate, if applicable.
  - f) The OBC applicant claiming reservation under the "OBC category" (if any vacancy reserved for OBC) must produce an OBC (Non-Creamy Layer) certificate, in the prescribed format (Annexure II), issued in Financial Year 2025-2026 (01.04.2025 to 31.03.2026). If during document verification, the applicant could not produce the OBC-

NCL certificate of the requisite time period (Issuing date from 01.04.2025 to 31.03.2026), his/her candidature shall not be considered under OBC-NCL category.

- g) The EWS applicant claiming reservation under the “EWS category” (if any vacancy reserved for EWS) must ensure that he possesses the Income & Asset certificate valid for the financial Year 2025-2026 issued on the basis of Income for the financial year 2024-2025. If during document verification, the applicant could not produce the EWS certificate of the requisite time period (Issuing date from 01.04.2025 to 31.03.2026), his/her candidature shall not be considered under EWS category.
- h) Where an applicant claims to belong to a Scheduled Caste, Scheduled Tribe or a Backward community it should be ensured that his/her community is included in the Central list of Scheduled Castes, Scheduled Tribes or OBCs, notified by the Government of India in relation to the concerned State.
- i) PwBD Category certificate only in respect of disability as indicated in the advertisement shall be admissible. Applicants must ensure to carry the original category clearing indicating the disability i.e., VI (B, LV) as mentioned in the advertisement.
- j) AADHAR Card.
- k) The applicant should have an active Aadhaar seeded bank account and same should be DBT enabled for Direct Benefit Transfer as per Govt of India norms.  
  
The same details should be submitted in the online application by applicants while applying. The Name and Date of Birth of the applicant should be the same as in the Matriculation (10th Class) Certificate, Aadhaar Card and in Bank Account.
- l) A medical fitness certificate from a Government Hospital must be produced during document verification.
- m) The applicant must also ensure that the final total marks in Degree/Diploma as claimed to be qualifying Degree/Diploma must be indicated in percentage. If this is not the case, a certificate indicating conversion to percentage issued by the university, etc. must invariably be submitted.
- n) One passport size latest photograph.

**Kindly Note:**

- Production of original documents along with self-attested copies is mandatory on the day of Document Verification of the selection process. In the absence of any original document, a self-attested copy of the same shall be accepted, subject to production of the same on the day of joining, if selected.
- However, if applicants are not able to produce either original or self-attested photocopies of the required essential documents as per advertisement for the respective post at the time of document verification, their Candidature shall **be REJECTED**.

- **The applicants appearing in the Document Verification should ensure that they fulfill the eligibility criteria. At any stage of the selection process if it is found that they are either not fulfilling the eligibility criteria or the documents submitted by the applicants are fake or the applicants have clandestine antecedents and have suppressed the said information, their candidature shall be rejected.**
- Please note that the Shortlisting for the engagement of Apprentices is “Provisional” and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Caste Certificate, etc. which he/she has mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the Apprenticeship will be treated as cancelled. If it is found that applicants have furnished false or wrong information, their candidature/apprenticeship will be rejected/ cancelled/ terminated at any time/ any stage.
