The Institute vide Advt. No. IITD/Apprentice (1) / 2024 dated August 28, 2024 invited online applications through NATS 2.0 portal for filling-up 30 vacancies of Apprentices in various Unit/Offices of IIT Delhi as detailed below:-

The following essential criteria as mentioned in the advertisement: -

#### Essential:

- 1. Bachelor's Degree/Diploma in relevant discipline as invited through NATS 2.0 portal with at least 55% marks in the qualifying degree/diploma.
- 2. The minimum age of the applicant must be 18 years, and the maximum age should not be beyond 25 years as on the last date of application. Relaxation in the upper age limit shall be applicable as per the Govt. of India guidelines for SC/ST/OBC/PwBD, etc.

- 3. The gap between the last date of application and the passing date of the qualifying degree/ diploma examination should not be more than two years.
- 4. The date of reckoning eligibility, i.e. qualification/ age was considered on the closing date of the Advertisement.

A total of 2112 applications received for engagement of Apprenticeship at IIT Delhi through NATS 2.0 portal. The Shortlisting cum Selection Committee has adopted following Shortlisting and Selection Criteria:-

### ADOPTED SHORTLISTING AND SELECTION CRITERIA:-

In addition to above essential eligibility criteria, the Shortlisting cum Selection Committee has decided to provisionally shortlisted the applicants in the ratio of 1:3 in respective categories (OTHERS/SC/OBC/EWS/PwBD) and respective part of Advertisement i.e., each Unit/Offices as per Part A, Part B and Part C Advertisement uploaded on NATS portal. The Criteria of provisionally Shortlisting and Selection of the applicants shall be based solely on the merit i.e., the percentage of the marks obtained in the Qualifying Degree/Diploma examination, as claimed by the applicant in application form alongwith mandatory eligibility criteria as mentioned above. The candidate's eligibility will be assessed based on the information provided in the online application form. No additional documents shall be entertained at this stage.

Initially, in the first round, the topmost applicants out of the provisionally shortlisted applicants as per vacancies advertised categorywise (OTHERS/SC/OBC/EWS/PwBD) in each Part A, Part B and Part C Advertisement uploaded on NATS portal will be initially provisionally selected for each Unit/Offices as per Part A, Part B and Part C Advertisement and will be called for Document Verification at later stage.

If the number of Selections after the first round falls short of the vacancies advertised, the remaining provisionally shortlisted applicants shall be invited in the second round for similar purpose as above from the remaining applicants in the list of provisionally shortlisted applicants in the order of merit.

The date of reckoning eligibility/ experience/ age will be counted on the closing date of the advertisement.

Please note that the Shortlisting and Selection for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Caste Certificate, etc. which he/she has mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the Apprenticeship will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature/apprenticeship will be rejected/ cancelled/ terminated at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the engagement altogether without assigning any reason thereof.
