PAYMENT DUE DATE & LATE FEE

1. From November 12th to 17th November 2021: Use the below link for payment of dues using SBI internet banking (without late fee) during this period
2. If the student does not pay his/her dues by 17th November,2021, then (a) Registration will be terminated, (b) Name will be struck off the rolls, (c) Hostel will have to be vacated and (d) All facilities will be withdrawn. To renew Registration, an additional charge of Rs.1750/-will have to be paid.
3. If any stage, internet-based payment process gets interrupted and the student does not get confirmation of payment on the web, he/she should get his passbook updated after 24 hours to check the status of the payment. If the payment has not been made, he/she has to repeat the payment process.
